PROGRAM HIGHLIGHTS

Baltimore's Digital Equity Fund Empowers Over 800 Residents through Expanded Digital Access

The Digital Equity Fund is driving meaningful change in the City's digital inclusion ecosystem. By investing in community partners to expand digital access, the fund is helping more than 800 residents take advantage of digital services and resources.

A major success of the fund is its ability to reach residents who are disconnected or only marginally

connected to the digital world. Through the efforts of grantees, residents are gaining access to high-speed internet, learning how to navigate online platforms, and receiving devices that enable them to participate fully in today's digital world. This expanded access is opening doors to new opportunities for education, employment, and civic engagement—fostering greater equity and inclusion across Baltimore.

The impact of expanded access is evident in the stories of individuals benefiting from

programs supported by the fund. From seniors learning to safely navigate the internet to job seekers gaining the digital skills necessary for today's workforce, the fund is making a tangible difference in the lives of Baltimore residents. By continuing to support and invest in community-driven efforts, the Digital Equity Fund is ensuring Baltimore's digital future is one where everyone can succeed.

In May 2024, <u>Mayor Brandon M. Scott announced a second round of funding</u>. For this second round of funding, Mayor Scott will announce grant recipients this October.

Launched April 2023, the Digital Equity Fund supports the creation of community-led digital inclusion plans and provides funding for communities to bring those plans to life. The fund currently supports 22 Baltimore-based organizations with over 27 digital inclusion projects

INITIATIVE HIGHLIGHTS

City's Chromebook Distribution Program Completes First Round with 30K+ Devices Distributed

The Baltimore Chromebook Distribution Program successfully completed its first round of distribution, reaching a significant milestone in the City's efforts to ensure digital access for all residents. In partnership with Enoch Pratt Free Library and a host of community partners, 35,000 Chromebooks have been distributed to low-income Baltimore households as of August 2024.

With the first round now complete, the program moves into its second phase of distributing an additional 15,000 devices for a total distribution of 50,000. The Baltimore Chromebook Distribution Program is a crucial component of the City's broader strategy to expand digital access and equity. By

providing residents with the necessary tools to connect to the internet, engage in online learning, apply for jobs, and access essential services, the program is helping to build a more inclusive and connected Baltimore.

In partnership with Enoch Pratt Free Library, Baltimore City is distributing 50,000 Chromebooks to eligible households in need of devices. We secured the Chromebooks through a grant from the State of Maryland's Connected Devices program.

What's the process for borrowing a device at a recreation center?

- 1. **Visit the Front Desk**: Speak with staff at the front desk to start the borrowing process. A valid ID is required, and borrowers must be 12 years or older. Borrowed devices must remain on site.
- 2. **Complete Rental Form**: Complete a rental form by submitting name, address, phone number, and email address.
- 3. Review Terms: Read and accept the rental terms:
 - Each resident can borrow one device for a 2-hour period.
 - Extensions may be possible upon request, depending on availability.
- Receive Device: Once the rental form is complete, staff will provide residents with a device, charger, and instruction manual.
- 5. **Use Device**: Handle the device with care and report any issues to staff immediately. Residents cannot install outside software without prior approval from recreation center staff.
- Return Device: After the rental session ends, return the device, charger, and instruction manual to the front desk. Staff will inspect the device for damages and issue a receipt to confirm the return.

By borrowing a device, residents agree to comply with all terms and conditions set by Baltimore City Recreation and Parks. Non-compliance may result in penalties or restricted access to future rentals.



Baltimore City Employees Take Advantage of Digital Skills Program

The City of Baltimore's Department of Human Resources (DHR), in collaboration with the Baltimore City Office of Information and Technology, successfully implemented the City of Baltimore Digital Skills Program. The program equips Baltimore City employees with the foundational computer skills and digital knowledge necessary to thrive both professionally and personally.

The program began as a pilot in June 2023, with a full citywide rollout in October 2023. Since its launch, over 200 Baltimore City employees completed the program. Key Baltimore City agencies, such as the Department of Public Works, the Department of General Services, and Baltimore City Recreation and Parks, received specialized training

To ensure ongoing development, DHR holds training sessions on the fourth Wednesday of every month at the DHR Lab, located at 7 E. Redwood Street, Floor 15. DHR tailors sessions to provide employees with the essential tools and knowledge to navigate the increasingly digital landscape of their work environment.

PARTNER SPOTLIGHT



This past July, Rebuild Johnston Square Neighborhood Organization (RJSNO) held the grand opening of the Johnston Square Community Computer Lab. A significant project supported by Baltimore City's Digital Equity Fund, the lab provides residents with access to essential technology and digital literacy programs.

In the presence of Baltimore City leadership, supporters, partners and residents, RJSNO celebrated the opening of the computer lab with a ribbon-cutting ceremony at Johnston Square's Mount Sinai Baptist Church (where the computer lab is located), marking another victory to close Baltimore's digital divide.

Founded in 2013, RJSNO's mission is to revitalize Baltimore's Johnston Square neighborhood by organizing community-driven initiatives focused on cleaning, greening, recreation, education, and public safety.

Major Milestone Reached with Deployment of FreeBmoreWiFi at Recreation Centers
